This website is partially compliant with the requirements outlined in Appendix A of the UNI CEI EN 301 549 standard due to the non-compliances listed below. Please note that the company does not fall within the scope of applicability of the Law 4/2004 and this declaration is provided on a voluntary basis. Therefore, the Company commits to making the non-accessible content compliant with the relevant regulations.

Non-accessible content

- The page language declared in the code is always English, even when the user browses in Italian. This affects the correct reading and pronunciation of various elements
- Several images or non-textual interactive elements lack alternative text
- The H1 header is missing on pages that instead begin with an H2 tag
- Items within the menu are read by the screen reader even when the menu is closed, affecting both reading and focus order
- There is no mechanism to skip directly to content when using assistive technologies (Bypass block)
- On the shop page, keyboard and screen reader navigation does not continue beyond the search bar
- Some interactive textual elements refer to visual sensory characteristics (e.g., buttons labelled "Click here")
- When browsing on mobile in landscape mode, some text elements overlap, and the "add to cart" button becomes unclickable
- Several interactive or textual elements do not have a sufficient contrast ratio of at least 4.5:1, and some non-textual elements do not reach the minimum of 3:1
- Text resizing, zooming up to 200%, and reflow are not fully supported, as some text overlaps
- There are image carousels that move automatically without the possibility of being paused
- When navigating using only the keyboard, not all interactive elements display a visible focus
- Forms are not fully accessible, as errors are not recognised or communicated, and suggestions for resolution are not provided.
